Checks should be made payable to the Manheim Area Chamber of Commerce.
- SALES**
- All items being sold/displayed must be in booth space.
- WEATHER**
- The event will not be cancelled because of rain, but you are permitted to not participate due to weather.
 - If weather prevents us from hosting what is deemed a “safe event”, you will be notified.
- CRITERIA**
- Vendor space is limited. Priority is given to first applicants and to members of the Manheim Area Chamber of Commerce.
 - Vendors who do not show up (unless due to weather) may lose their positions in future months.
 - Direct sales vendors will not be approved to participate.

General Information

The Manheim Area Chamber of Commerce strives to maintain a balance and diversity in vendor offerings. All applications and products are reviewed so that we may maintain this balance. Our goal is to keep standards high and promote a safe, successful and fun event. The policies and regulations set forth in this document are designed to maintain order and to regulate activities in the downtown area.

Conditions

1. All locations will be assigned by the Manheim Area Chamber of Commerce. The assigned locations will be on the outer sidewalks of Market Square and potentially the Mini Park. During cold weather months, vendors may be moved to an indoor location.
2. Vendors are required to keep a neat, presentable booth at all times. Empty boxes and trash will not be permitted around the booth. If you are selling items that generate trash, trash receptacles must be included in your setup.
3. Vendors using tents or canopies must use weights to secure their tent for the sake of safety—that of visitors, neighboring vendors, and themselves.
4. It is the sole responsibility of each vendor to obtain the applicable and appropriate state and local licenses and permits as well as payment of taxes pertaining to their operation.
5. The Manheim Area Chamber of Commerce will not provide access to electric or water.
6. Vendor agrees to hold the Manheim Area Chamber of Commerce and Manheim Borough harmless for any injury, theft or other loss that may occur to property or person during the load-in/set-up, event, and break-down/load-out of the event.
7. Approved vendors are to display and sell only their own products and services as described and submitted in the application on the following page. Separate businesses may not display or vend from an approved vendor's space without approval from the Manheim Area Chamber of Commerce.
8. Vendors are not to begin striking their display until 8 pm. Exhibits must remain open until event closing, even if exhibitor is sold out. Vendors who leave early may not be invited to participate in future months.
